TREASURER'S REPORT ON THE 1974/5 SESSION

The Society's income was little changed from the previous session while expenditure rose in response to inflationary pressures. The reduction in the number of pages in each part of the Bulletin, Journal and Proceedings achieved a substantial saving, without which the position would have been far worse. At $\pounds 9,153$ the surplus of income over expenditure shows a fall of over $\pounds 6,000$ from the corresponding figure for the previous session. Further increases in costs are undoubtedly on the way, but the new subscription rates should help to offset this.

The market value of investments in the Society's General Funds rose from $\pounds74,698$ to $\pounds129,514$, due to the recovery of the Stock Market, while Bank deposits were built up from $\pounds17,385$ to $\pounds22,884$. Dividends

and interest brought in £9,911, as compared with £8,970 in the previous session. The experience of the Trust Funds was similar. Members subscriptions were slightly down at £8,613, as compared with £9,313. Notable features on the income side were the receipt of £5,117 from Russian Mathematical Surveys and £3,524 from sales of back numbers. Without our investment income, however, there would have been no overall surplus.

In these anxious times it is difficult to look ahead with any certainty and members will, I feel sure, wish Council to direct the Society's affairs with caution. This points, I fear, to some continuation of the economy measures imposed at the beginning of the year, but otherwise a full programme is planned for 1976.

LIBRARY AGREEMENT

I reported to you, in a previous Newsletter, that the L.M.S. was negotiating a new library agreement with University College London with a view to relieving ourselves of many of the costs incurred by the library, which had been of the order of £2,000 per annum. I am pleased to report to you that agreement has been reached and became effective on 1 January 1975. The exact details of the library agreement are too complex to report here but the two main points are as follows: Firstly, University College has agreed to take over the purchasing of those periodicals previously purchased by the L.M.S. Secondly, University College has agreed to pay for the cost of binding the periodicals which we receive on an exchange basis in return for becoming joint owners of the periodicals so bound. D. G. SENIOR BERWICK PRIZE

At the June meeting, 1976, of the Society the Council will be awarding the Society's Senior Berwick Prize. Accordingly it has appointed the following as the 1976 Prize Committee: Professor M. F. Atiyah (Oxford), Professor P. M. Cohn (Bedford College) and Professor F. F. Bonsall (Edinburgh).

The Council invites members of the Society to submit their views confidentially in writing to any member of the Committee by 1 March. Council reserves the right not to make an award if a candidate of sufficient merit is not recommended by the Prize Committee.

The principal points that members should note are:

(1) The Prize will be awarded in respect of a definite piece of work published by the Society in any of its publications (at present the three periodicals, the Monographs, and the Lecture Notes Series) in the period 1 January, 1972, until 31 December, 1975.

(2) The members of the Prize Committee are ineligible for the award.

(3) Only mathematicians who are members of the Society at the date of the award are eligible for the Prize.

(4) No member can receive the Senior Berwick Prize more than once; winners of the Junior Berwick Prize are not however disqualified from eligibility. This regulation then excludes only the following members from eligibility: Messrs. P. Hall, J. E. Littlewood, G. Higman, W. K. Hayman, F. F. Bonsall, G. L. Watson, A. W. Goldie, R. Rado and P. M. Cohn.
